Competition entry will commence from the announcement of a special phrase during the livestream and winners will be randomly selected before the end of the Live Station show.

1. Organiser: UNIQLO Europe Ltd, 103-113 Regent Street, London, W1B 4HL ("UNIQLO")

2. Competition Schedule:

The UNIQLO Live Shopping Competition (the "Competition") will be held on March 28, 2023 from 1:00 p.m. until the organiser announces that the competition is closed (no later than 2.00 pm on March 28, 2023), All entries must be submitted and received during the competition during the Live Station (the "Contest Period").

3. Prize

The prize consists of 20x UNIQLO Coach Jackets as shown during the Live Station live on March 28, 2023. 20x winners will be selected at random from eligible participants, 1x prize per person.

4. Eligibility:

The Competition is open only to United Kingdom residents aged 18 or over, who are of legal age on the date of registration. Participation implies the participant's full acceptance of these rules (the "Rules") and the decisions of the Organiser, which are deemed final and binding. Participating and winning a prize implies compliance with these Rules.

5. Entry:

Entries must be received during the Contest Period. Participants must submit the correct competition code along with their name, email address, city and agree to the terms and conditions and opt-in to the UNIQLO newsletter.

Each entry must be submitted directly by the participant. Each participant agrees to provide their details to the organiser and third parties for the purposes of administering the Competition and in order to comply with applicable laws, regulations and rules.

One entry per person. Entries that are received by the Organiser outside of the Contest Period will be deemed void.

#### 6. Winner selection and notification:

20x winners will be selected on the same day (March 28, 2023). The winners will be selected using a random selection generator and will be notified during the livestream and by email within 24hrs of the livestream ending.

If a winner:

- (i) cannot be contacted;
- (ii) fails to respond within five (5) days from the date they are contacted; and/or
- (iii) the prize or prize notification is returned to UNIQLO, UNIQLO may select another potential winner as a substitute. By contacting a potential winner and in the event that he/she has satisfied all the eligibility requirements of the Competition, this person will be declared a replacement "winner" of the Competition.

#### 7. Limitations of liability:
